TO WHOM THIS MAY CONCERN:

Upon the written request of MS. ANGELICA "ANGEL" ANADON - Secretariat, United Nations Interfaith Harmony Partner-Zamboanga, this city, **PERMIT** is hereby granted to install/hang **Nine (9) pcs. 3 ft x 6 feet Tarpaulins** with the text "World Interfaith Harmony Week" from January 31 to February 7, 2015 at the following area/s, to wit:

Alongside:

1. Bangko Sentral (fronting Paseo del Mar)
2. Zamboanag City Pier (entrance)
3. Zamboanga International Airport (entrance)
4. Western Mindanao State University
5. Veterans Ave. intersection
6. Baliwasan intersection
7. Sta. Cruz intersection
8. Stsa. Cruz overpass
9. Gov. Camins

CONDITIONS:

1. That the posters or advertisement cloth or papers not ensured in frames shall be hang at a height sufficient enough to allow passage of vehicular traffic not less than 16 feet from the ground
2. That should it be necessary to put poles for the purpose alongside the road, the same shall be planted where it will not interfere with the free flow of water in the canals and in such a manner as not to damage the concreted and/or asphalted portion of the road;
3. The sidewalk shall not be utilized for the aforesated purposes;
4. That it is understood that hanging of streamers on fences shall be with the approval of the lot owner or of the administrator, that if hung/placed in front private business establishment, prior consent from the owner or management of the business establishment or private property to where streamers will be posted or hung must be secured.
5. That vehicular traffic shall not be interrupted during the hanging and removal of the streamers, advertisements, etc.;
6. Where there are telephones or electric wires, utmost care shall be exercised that the strings, ropes, or wires to be used shall not come in contact with the former;
7. That the permittee shall be held liable for any injury or damage to, or loss of loss of life or property if the same has been caused as a result of carelessness or lack of precaution on the part of the applicant or his agents in connection herewith;
8. That before commencing the work, the City Electrician should be consulted with a view to eliminate the possibility or contact with the telephone or live electric wires.
9. Streamers should be changed or removed as soon as it becomes unsightly.
10. That after the purpose of which the permit herein applied for had been served, the posters, streamers, advertisements poles, etc., should be removed within seven (7) days after expiration of the permit and the excavation in the area if any, filled back and the premises returned to their original conditions;
11. **Absolutely no hanging of drop down banners on City Post/ZAMCELCO Post/or any private utility posts.**
12. **That except for political, religious, educational or scientific advertisement, including City Tourism activities and fiestas or election propaganda material,** the City shall charge P 50.00 for each streamers, banners, posters and a separate refundable deposit of P 50.00. For streamers, banners and posters exceeding 32 sq. ft., a fee of P 500.00 will be charged and a deposit of P 500.00 will be applied. Failure to remove streamers, banners and posters after the period given shall forfeit the deposit in favor of the City Government per City Ordinance No. 333 known as "An Ordinance Regulating and Penalizing the construction, installation, posting or display of temporary arches and billboards, banners, streamers, placards, commercial and non-commercial advertisement or the flying of signs within the City of Zamboanga".
13. **PENALTIES** - Any person, firm or entity violating any provision of the City Ordinance No. 333 shall be punished by a fine of not less that P 3,000.00 not more than P 5,000.00 per violation or suffer imprisonment of not less than ten (10) days nor more than thirty (30) days or both fine and imprisonment at the discretion of the court. If justice can be served best and the apprehend person(s) opted to pay an administrative fine of Three Hundred Pesos (P300.00) per violation, the same shall be accepted and the case is settled amicably. In case of violation by association, firm or corporation, the president and its corporate officers, manager or agent thereof, shall be held liable.
